BOOTH COST

A cashier check, money order must accompany your application or your booth will not be confirmed. You may also pay in cash in our office. **We do not accept personal checks, however you can use a personal check for the cleaning deposit fee.**

Business Booth Fee = \$300

Cleaning Deposit Fee = \$100 cash or check, fully refundable if the booth is left clean at the end of the festival.

We require a deposit of half of the booth fee now (\$150) to secure your reservation + the cleaning fee deposit.

This booth fee deposit is non-refundable. Full payment for your business booth is due July 19, 2021.

A confirmation email will be sent to you once we have received your application and payment in full.

LIST ALL ITEMS TO BE SOLD IN YOUR BOOTH:

PLEASE NOTE: The National Tongan American Society reserves the right to sell DRINKS, therefore, vendors will NOT BE ALLOWED to sell any type of drinks. All vendors are responsible for obtaining all permits necessary to operate during the festival. If the necessary permits are not obtained, you will not be allowed to sell your products at the Friendly Island Festival 2021.



IMPORTANT VENDOR INFORMATION

YOU must provide:

- One 10" x 10" booth, fire extinguisher
- All business booths must provide their own tables, chairs, and lights for the evening.

IMPORTANT DATES

- All applications close at 5:00pm on Thursday, July 19th, 2021. **FULL PAYMENT IS ALSO DUE** on this day.
- Set up time is August 12th at 8:00am. All booths open to the public at 4:00pm on the same day.
- **Electricity is not available. If you need an electric hookup, please let us know in advance.**

AGREEMENT

I understand that The National Tongan American Society Festival Committee may remove, eject or evict any person, organization, group, or entity which engages in activities it deems contrary to the well-being or safety of any participant, person, community or group. I acknowledge receipt of the rules governing the use of booth space at the Friendly Islands Tongan Festival and agree to abide by those rules.

I understand that I will forfeit my cleaning deposit of \$100 if the booth space is left uncleaned. I understand that the required deposit of half the booth fee (\$150) is non-refundable if I decide to cancel.
